Rangeland health reference sheet

Interpreting Indicators of Rangeland Health is a qualitative assessment protocol used to determine ecosystem condition based on benchmark characteristics described in the Reference Sheet. A suite of 17 (or more) indicators are typically considered in an assessment. The ecological site(s) representative of an assessment location must be known prior to applying the protocol and must be verified based on soils and climate. Current plant community cannot be used to identify the ecological site.

Indicators

2.	Presence of water flow patterns: Water flow patterns are none to few (short <1 m and disconnected) and can be expected in areas subjected to summer convection storms or rapid snowmelt. Flow patterns are meandering and are interrupted by plants and exposed rocks.
3.	Number and height of erosional pedestals or terracettes: Pedestals are none to rare. Occurrence is usually limited to areas of water flow patterns. Frost heaving of shallow rooted plants should not be considered a "normal" condition. Terracettes are none to rae.

1. Number and extent of rills: Rills are none to rare. A few can be expected on steeper slopes in areas subjected to

5. Number of gullies and erosion associated with gullies: None

bare ground): Bare Ground 30-40% depending on amount of surface rock fragments.

7.	Amount of litter movement (describe size and distance expected to travel): Fine litter (foliage from grasses and annual & perennial forbs) expected to move distance of slope length during intense summer convection storms or rapid snowmelt events. Persistent litter (large woody material) will remain in place except during large rainfall events.
8.	Soil surface (top few mm) resistance to erosion (stability values are averages - most sites will show a range of values): Soil stability values should be 3 to 6 for most surface soil textures found on this site.
9.	Soil surface structure and SOM content (include type of structure and A-horizon color and thickness): Surface structure is typically moderate, medium platy or granular. Surface textures are typically loams or silt loams. Soil surface colors are grayish browns and soils are often typified by a thin mollic epipedon. Organic matter of the surface 2 to 3 inches is typically 1 to 1.5 percent dropping off quickly below. Organic matter content can be more or less depending on micro-topography.
10.	Effect of community phase composition (relative proportion of different functional groups) and spatial distribution on infiltration and runoff: Perennial herbaceous plants (especially deep-rooted bunchgrasses [i.e., bluebunch wheatgrass & Indian ricegrass] slow runoff and increase infiltration. Shrub canopy and associated litter break raindrop impact and provide for snow capture on the site.
11.	Presence and thickness of compaction layer (usually none; describe soil profile features which may be mistaken for compaction on this site): Compacted layers are none. Subsoil calcic horizons or duripans are not to be interpreted as compacted layers.
12.	Functional/Structural Groups (list in order of descending dominance by above-ground annual-production or live foliar cover using symbols: >>, >, = to indicate much greater than, greater than, and equal to):
	Dominant: Reference State: Deep-rooted, cool season, perennial bunchgrasses (bluebunch wheatgrass & Indian ricegrass) >> low shrubs (black sagebrush
	Sub-dominant: associated shrubs > shallow-rooted/rhizomatous, cool season, perennial bunchgrasses > deep-rooted, cool season, perennial forbs = fibrous, shallow-rooted, cool season, perennial and annual forbs
	Other: evergreen trees, microbiotic crusts
	Additional: With an extended fire return interval, the shrub component will increase at the expense of the herbaceous component. Singleleaf pinyon and Utah juniper may eventually increase and dominate the site.
13.	Amount of plant mortality and decadence (include which functional groups are expected to show mortality or decadence): Dead branches within individual shrubs common and standing dead shrub canopy material may be as much as 20% of total woody canopy; some of the mature bunchgrasses (<10%) have dead centers.
14.	Average percent litter cover (%) and depth (in): Within plant interspaces (20-30%) and depth of litter is <1/4 inch

	production): For normal or average growing season (through mid-June) ± 600 lbs/ac. Favorable years ~800 lbs/ac and	
	unfavorable years ~400 lbs/ac.	

- 16. Potential invasive (including noxious) species (native and non-native). List species which BOTH characterize degraded states and have the potential to become a dominant or co-dominant species on the ecological site if their future establishment and growth is not actively controlled by management interventions. Species that become dominant for only one to several years (e.g., short-term response to drought or wildfire) are not invasive plants. Note that unlike other indicators, we are describing what is NOT expected in the reference state for the ecological site: Potential invaders include cheatgrass, annual mustards, halogeton and Russian thistle. With a change in the historic fire return interval, singleleaf pinyon and Utah juniper can increase and dominate on this site.
- 17. **Perennial plant reproductive capability:** All functional groups should reproduce in average (or normal) and above average growing season years. Little growth or reproduction occurs in extreme drought years.
